Subject: TC Sponsored Participation Regional Training Course on Basic Clinical PET/CT, Debrecen, Hungary from 26 to 30 November 2018

Dear National Liaison Officer/National Coordinator,

I am pleased to invite you to send nominations of suitable candidates to participate in the TC Sponsored Participation Regional Training Course on Basic Clinical PET/CT within the framework of the IAEA technical cooperation project RER6037, "Strengthening Nuclear Medicine Capabilities". Selection of participants will be in accordance with IAEA procedures.


The purpose of the event is to provide medical practitioners with introductory theoretical and practical training in state of the art hybrid imaging using PET/CT. The programme is opened to up to 10 participants from countries that participate in the RER/6/037 project and need assistance in training staff for hybrid imaging methodology. The nominees should be qualified Nuclear Medicine Physicians and/or Radiologists, currently working in Nuclear Medicine/Radiology departments, with strong commitment to provide hybrid imaging services (such as PET/CT). Nominations of oncologists who wish to have exposure to nuclear medicine applications with a view of implementing in their practices are also acceptable.

The IAEA will provide selected participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Debrecen. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.

We would appreciate receiving your country's nominations by **21 September 2018** through the IAEA's InTouch+ platform (<https://Intouchplus.iaea.org>). Should this not be possible, applicants may download the Nomination Form for the course from the [IAEA's webpage](#). Please be advised that late nominations or replacements of participants after the closing date for nominations will not be accepted.
