Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER7011, “Enhancing the Inventory of Aerosol Source Profiles Characterized by Nuclear Analytic Techniques in Support of Air Quality Management”.

The purpose of the event is to train participants in using advanced statistical tools for source apportionment in air pollution studies.
