I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER1021, "Enhancing the Use of Radiation Technologies in Industry and Environment".

The purpose of the event is to train the participants on the theoretical and practical aspects of using ionizing radiation for cultural heritage preservation, conservation and consolidation.
