Subject: Regional Stakeholder Engagement Meeting on Early Support to Sterile Insect Technique Pilot Trials against Aedes Mosquitoes, Bologna, Italy, from 4 to 6 April 2022

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER5026, "Enhancing the Capacity to Integrate Sterile Insect Technique in the Effective Management of Invasive Aedes Mosquitoes".

The purpose of the event is to discuss with local and regional relevant stakeholders involved in mosquito control, health policy authorities and funding organizations the establishment of the required policy framework and funding mechanisms to implement pilot trials on Sterile Insect Technique (SIT).

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify suitable women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Bologna. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.

Should this not be possible, applicants may download the Nomination Form for the course from the IAEA's webpage.
