Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER9153, “Enhancing the Regional Capacity to Control Long Term Risks to the Public due to Radon in Dwellings and Workplaces”.

The purpose of the event is to discuss and share experience on quality assurance of radon measurements using passive track detectors and demonstrate technical capacity necessary.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant’s residence and Berlin.
