Subject: Interregional Meeting on Inspections for Transport of Radioactive Material, Stockholm, Sweden, from 11 to 15 May 2020

Dear National Liaison Officer / National Coordinator.

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project INT9184, "Enhancing Transport Safety Infrastructure in Mediterranean Region Member States through Sustainable Collaboration".

The purpose of the event is to discuss and agree on the arrangements necessary to harmonize common procedures and guidelines for authorization and inspection of transport of radioactive material

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify suitable women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Stockholm. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
