## **Information Sheet**

#### **Purpose**

The purpose of the event is to review the project workplan and fine-tune the project activities.

# **Working Language**

The working language of the event will be English.

#### **Deadline for Nominations**

Nominations received after 16 March 2022 will not be considered.

### **Project Background**

The number of outbreaks of emerging and re-emerging animal diseases worldwide is increasing. Environmental and climate changes, melioration in conjunction with global movement of animals and wildlife are creating favourable conditions for animal to wildlife interface. Since wild animal species are recognized as potential pathogen reservoirs they can maintain infectious diseases in the environment and interfere with the effectiveness of disease eradication programmes. Therefore, for the domestic animal and wildlife surveillance, updating/implementing nuclear derived techniques, such as real time polymerase chain reaction (PCR) and next generation sequencing (NGS) are important tools for the early detection and characterization of transboundary animal diseases (TAD) since a lack of early disease recognition can allow the circulation of pathogens for weeks, resulting in their spread and interspecies transmission.

The aim of this project is to enhance the preparedness in animal disease early recognition by: (1) establishing/upgrading diagnostic capacities in regard to the different prevailing conditions in participating countries; (2) establishing a network to assist designating laboratories in protocol harmonization and early detection of animal diseases and (3) developing/upgrading protocols for wildlife infectious disease surveillance. The project would also enhance communication and collaboration among stakeholders in veterinary and wildlife sectors at both the national and regional level by joint workshops, trainings and conferences.

### Scope and Nature

The scope of the meeting is to discuss the priorities of the counterpart institutions or laboratories and to decide on the topics for the project events, including the priority procurement (equipment and consumables) needs.

### **Expected Outputs:**

The project workplan reviewed and activities agreed.

### **Participation**

The regional training course is open to 30 participants from Member States participating in the new TC project RER5027.

Each Member State is invited to nominate up to 2 participants who must match the profile described in the corresponding paragraph, indicating the order of priority.

### Participants' Qualifications and Experience

The meeting is open to the staff members or representatives of the designated counterpart institutions/ relevant laboratories from TCEU Member States.

## **Application Procedure**

Candidates wishing to apply for this event should follow the steps below:

- 2. On the InTouch + platform, the candidate must:
  - a. Finalize or update her/his personal details, provide sufficient information to establish the required qualifications regarding education, language skills and work experience ('Profile' tab) and upload relevant supporting documents;
  - b. Search for the relevant technical cooperation event (EVT2201827) under the 'My Eligible Events' tab, answer the mandatory questions and lastly submit the application to the required authority.

**NOTE:** Completed applications need to be approved by the relevant national authority, i.e. the National Liaison Office, and submitted to the IAEA through the established official channels by the provided designation deadline.
