Subject: Regional Workshop on Predisposal Options for Small Amount of Institutional Radioactive Waste, Vienna, Austria, from **8 to 12 August 2022**

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project **RER9154**, "Enhancing the Implementation of Integrated Programmes for the Safe Management of Radioactive Waste".

The purpose of this **Regional Workshop** is to present the best practices and exchange of experiences in the region associated with the practical steps needed to select appropriate and efficient technologies for processing and storage options of relatively small volumes of radioactive waste from different nuclear applications.

The attached Information Sheet provides further details, including technical and administrative aspects of the Seminar. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify suitable women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Vienna. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.

Please be advised that late nominations or replacements of participants after the closing date for nominations will not be accepted.
