Subject: Interregional Training Course on Safety and Impact Assessment for Decommissioning Projects, Angra dos Reis, Brazil, from 19 to 23 September 2022

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project INT2020, "Enhancing Capacity Building to Promote Successful Decommissioning and Environmental Remediation Projects".

The purpose of the event is to train the participants in safety assessment for the decommissioning of nuclear facilities including the application of a graded approach to a range of potential facilities and activities; and the implementation of safety measures.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify suitable women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Angra dos Reis. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.

Should this not be possible, applicants may download the Nomination Form for the course from the IAEA's webpage. Please be advised that late nominations or replacements of participants after the closing date for nominations will not be accepted.
