Subject: Regional Workshop on Quality and Safety in Diagnostic and Interventional Radiology, Astana, Kazakhstan, from 27 to 30 June 2023

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER6042, "Building Capacities of Medical Physicists in Diagnostic Radiology to Support the Establishment of Quality Management Systems".

The purpose of the event is to discuss and share experience in quality and safety in diagnostic and interventional radiology through implementation of the requirements of the International Basic Safety Standards - General Safety Requirements (GSR) Part 3.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Astana or a travel allowance to purchase an air ticket. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
