I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER9155, "Enhancing Regulatory and Metrological Infrastructures Needed to Ensure Radiation Safety in Naturally Occurring Radioactive Materials Industry".

The purpose of the event is to discuss and assess the findings and results of the regional intercomparison exercise on radioanalytical analysis of Naturally Occurring Radioactive Materials (NORM) samples which was conducted under the TC project RER/9/155.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.
