Dear National Liaison Officer / National Coordinator.

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER2018, "Analyzing Low Carbon Pathways towards an Ambitious Decarbonized Energy Sector by 2050".

The purpose of the event is to provide a platform for knowledge exchange among energy analyst that want to consider nuclear power as one of the options for a transition towards a low carbon power system and net zero targets.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Vienna or a travel allowance to purchase an air ticket. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
