I am pleased to invite you to send nominations of suitable candidates to participate in the TC Sponsored Participation to attend the European Congress of Radiology (ECR 2024) within the framework of the IAEA technical cooperation project RER9157, "Strengthening Implementation of the Justified and Optimized Use of Ionizing Radiation in Medicine".

The Congress will focus on "*Next Generation Radiology*" and will provide participants with information on cutting-edge technology and practices in healthcare. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
