Subject: Regional Workshop on the Role of Electricity Grid in the Decarbonization Efforts, Ankara, Türkiye, from 20 to 24 May 2024

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER2018, "Analyzing Low Carbon Pathways towards an Ambitious Decarbonized Energy Sector by 2050".

The purpose of the event is to facilitate discussions and exchange experiences on the role, challenges, and opportunities of the electricity grid in decarbonizing the energy system, as well as to discuss modelling approaches that capture the interactions of decarbonization efforts with grid development.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Ankara or a travel allowance to purchase an air ticket. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
