Subject: Invitation to School of Drafting Regulations for Waste Safety, Vienna, Austria, from 17 to 28 February 2025

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER9158, "Strengthening the Regulatory Infrastructure for Radiation Safety".

The purpose of the workshop is to support participating Member States to complete their draft regulations on the management of radioactive waste, disused radioactive sources and regulations related to the decommissioning of nuclear facilities in line with IAEA safety standards with the assistance of international experts.

The attached **Information Sheet** provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Vienna or a travel allowance to purchase an air ticket. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.

Should this not be possible, applicants may download the Nomination Form for the course from the [IAEA's webpage](#). Please be advised that late nominations or replacements of participants after the closing date for nominations will not be accepted.
