Subject: Regional Workshop on Radiation Processing Dosimetry with Focus on Uncertainties Measurement and Digital Oscillometric Evaluation of Electronic Control Box Dosimeters, Budapest, Hungary, from 14 to 18 October 2024

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER1024, “Enhancing the Use of Radiation Technologies for Improved Resource Efficiency”.

The purpose of the workshop is to discuss and exchange experience on radiation processing dosimetry and recent approaches to measurement uncertainty in dose conformity assessment.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.
