I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER9163, "Improving the Protection of Workers Exposed to Radiation at Naturally Occurring Radioactive Material Sites".

The purpose of the event is to discuss establishing national legal framework that ensures compliance with the of GSR Part 3 requirements for workplaces monitoring for naturally occurring radioactive material (NORM), focusing on radiation protection of occupationally exposed workers.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Banska Bystrica or a travel allowance to purchase an air ticket. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
